- 1. Notice is hereby given that the Council of the London Borough of Camden ('the Council') propose to make the above Orders under section 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.
- 2. The general nature and effect of the Orders would be:-
  - in ANGLERS LANE, on the north-west side, adjacent to No. 52 Alma Street, to remove 5.5 metres of CA-L permit holders parking space and provide an e-scooter and cycle hire parking place;
  - (b) in CATHCART STREET: (i) on the north-east side, approximately 13 metres south of the vehicle entrance to Azania Mews, to remove 5.5 metres of CA-L permit holders parking space and provide 'at any time' waiting restrictions ('double yellow lines'); (ii) on the south-west side, approximately 25 metres south-east of Holmes Road to remove 4.9 metres of double yellow lines and extend the adjacent 'school keep clear' markings; and (iii) in order to improve sightlines at its junction with Inkerman Road (A) on the north-east side, adjacent to No. 36 Inkerman Road, to remove 6.4 metres of CA-L permit holders parking space and replace it with double yellow lines; and (B) on the south-west side, adjacent to No. 37 Inkerman Road, to relocate the car club parking place 5.5 metres north-westwards, replacing CA-L permit holders parking space, and extend the existing double yellow lines north-westwards by 5.5 metres;
  - (c) in HOLMES ROAD, to provide double yellow lines on both sides, between Raglan Street and No. 48 Holmes Road, except where the 'school keep clear' marking is marked on street, removing the permit holders parking places on the north-east side of this length of road and shortening the zigzag markings extending north-west of the western kerb-line of Raglan Street so they extend 2.9 metres north-west of that kerb-line;

- (d) in RAGLAN STREET, on the west side of the junction of the south-west to north-east arm and the north-west to south-east arm, to remove 11 metres of CA-L permit holders parking space and provide double yellow lines in front of a proposed kerb build-out;
- (e) in order to improve sightlines at junctions, to remove CA-L permit holders parking space and replace it with double yellow lines in the following locations (lengths given in brackets, below):
  - (i) ALMA STREET: (A) north-east side, outside Nos. 25 to 27 Alma Street (7.1 metres); and (B) south-west side, adjacent to No. 5 Inkerman Road (6.9 metres);
  - (ii) INKERMAN ROAD: (A) north-west side: (I) adjacent to No. 33 Willes Road (2.3 metres); and (II) outside Nos. 37 and 38 Inkerman Road (3.9 metres); (B) south-east side: (I) adjacent to No. 31 Willes Road (5.5 metres); (II) outside Nos. 3 to 5 Inkerman Road; and (III) adjacent to No. 25 Alma Street (6.3 metres);
  - (iii) WILLES ROAD: south-west side, outside Nos. 29 and 32 Willes Road (5.4 metres).

### STATEMENT OF REASONS

Streets in the area around Holmes Road between Prince of Wales Road and Kentish Town Road are primarily residential in nature and home to two schools.

Large volumes of traffic use Holmes Road, as well as other streets in the area, as a cut-through to avoid the traffic lights at the junction of Prince of Wales Road and Kentish Town Road.

In order to provide children (and parents) with the opportunity to travel to and from school in a safer environment, a trial Healthy School Street (timed road closure) was introduced on Holmes Road outside St Patrick's Primary School in May 2022, in addition to an 'at all times' motor vehicle restriction on Raglan Street.

To improve access to properties on Raglan Street, the one-way southbound designation of Anglers Lane between Alma Street and Willes Road was removed.

In response to feedback received and monitoring undertaken during the trial period, these trial elements were made permanent, and several new schemes/measures were proposed, consulted upon and approved via a decision report published in November 2023.

Traffic Management Orders are required to facilitate the following measures:

- (a) double yellow lines marked in front of pavement widening on Raglan Street to provide space for additional trees and plants;
- (b) a new dockless e-scooter and cycle hire bay on Anglers Lane to increase access to active travel modes; and
- (c) double yellow lines at junctions (as part of Camden's Junction Protection Programme) to improve accessibility, visibility and safety at junctions.
