

**LONDON BOROUGH OF CAMDEN**
**NOTICE OF VARIATION OF CERTAIN ON-STREET PARKING AND PERMIT CHARGES AND PARKING PLACE SUSPENSION FEES**

Notice is hereby given that the Council of the London Borough of Camden, under section 46A of the Road Traffic Regulation Act 1984, will increase the charges payable in respect of certain types of on-street permits, at certain paid-for on-street parking places, and in relation to the suspension of on-street parking places – as detailed below. The new charges will take effect from either 01 May 2025, or 01 October 2025, depending upon the type of charge. Permits are issued or granted subject to eligibility criteria details of which can be found at [camden.gov.uk/parking-permits](https://camden.gov.uk/parking-permits) .

**1. Residents' permits** - Permit Charge applicable in respect of vehicles left in 'CA'-prefixed resident permit holders or permit holders parking places. An air quality surcharge also applies to certain types of vehicle registered to the permit which is payable again on renewal of the permit.
