## Road Traffic Regulation Act 1984 – sections 35C and 46A:

### Notice of variation of certain on-street parking and permit charges, off-street permit charges and parking place suspension fees

Notice is hereby given that the Council of the London Borough of Camden, under sections 35C and 46A of the Road Traffic Regulation Act 1984, will increase the charges payable in respect of certain types of on-street and off-street parking permits, at certain paid-for on-street parking places, and in relation to the suspension of on-street parking places – as detailed below. The new charges will take effect from 01 May 2024. Permits are issued or granted subject to eligibility criteria details of which can be found at [camden.gov.uk/parking-permits](https://camden.gov.uk/parking-permits) .

#### 1. Market traders permits

Charges applicable to market traders in respect of vehicles left in parking places in the vicinity of the market operating in the street indicated where the adjacent sign includes the words “Permit holders” together with the permit identification code “MKT” or a code beginning with the letter “T”. A charge is also made for each diesel powered vehicle registered to the permit which is payable again on renewal of the permit.
